

# PRIVACY STATEMENT BLACK STALLION B.V.

## PERSONAL DATA THAT ARE STORED AND/OR PROCESSED

**Black Stallion B.V.** may process some personal data about you because you may use the services of **Black Stallion B.V.** and/or because you have provided these yourself, for example by sending us an e-mail, handing over a business card, or if you provided these by filling out a contact form on the website of **Black Stallion B.V.**

**Black Stallion B.V.** may process the following personal data:

- Your first and last name
- Your business address data
- Your business telephone number
- Your business e-mail address
- Your business IP-adress

## WHY BLACK STALLION B.V. NEEDS SOME OF YOUR PERSONAL DATA

**Black Stallion B.V.** stores and processes as little personal data as practically possible, but may process some of your personal data in order to be able to contact you by phone if you request for this, and/or to be able to contact you in writing (by e-mail or by letter), in case our attempts to reach you by telephone are unsuccessful.

If you are a potential supplier for goods or services, **Black Stallion B.V.** may contact you in the capacity as your company's contact person, using your business contact details if these are known publicly (for example in your employer's website).

In addition, **Black Stallion B.V.** may use your personal data (limited to the data in your capacity as contact person for your company or employer) in relation to negotiations about, and the execution of a contract or agreement between **Black Stallion B.V.** and you, respectively your employer or company, usually in relation to the purchase or sale of services or products.

**Black Stallion B.V.** will make all reasonable efforts to limit your personal data stored or processed, to the data that are absolutely necessary to contact you in your role as an owner and/or representative of an organization and/or company, and will refrain from storing or processing any personal data about you than listed above.

While **Black Stallion B.V.** may contact the contact persons of its (potential) suppliers or (potential) customers with offers, requests for offers, requests for appointments and other standard business communications, **Black Stallion B.V.** will NOT use such personal data about you for mass communications, unsolicited news letters or any other generic communication, not specifically intended for you in your business role.

**Black Stallion B.V.** may occasionally issue news communications, but will ONLY send these to those persons and organizations that have specifically agreed to subscribe to these. A simple e-mail or phone call to us is sufficient to cancel such subscription. Also, any such news communication will contain a link to cancel the subscription.

## HOW LONG WILL BLACK STALLION B.V. STORE PERSONAL DATA

**Black Stallion B.V.** will not keep and store your personal data any longer than is necessary to achieve the purpose for which your data have been collected. If no business activities, contracts or agreements are achieved between **Black Stallion B.V.** and you, your employer or your own company, your personal data will be deleted after two years. If we acquire knowledge that you are no longer

active as a contact person for the business or organization in connection with which we received these data, we will delete these immediately by our own initiative.

## SHARING WITH THIRD PARTIES

**Black Stallion B.V.** will provide your personal data (limited to those listed above) only to third parties if this is necessary to execute an agreement with you, your company or your employer, or to comply with any legal obligation. **Black Stallion B.V.** does not sell any personal data to any third party..

## MONITORING WEB SITE VISITS

On **Black Stallion B.V.**'s web site, general data about visitors may be monitored, among which the IP-address of your computer and the date and time of the access to page of the website, and data that your browser may send. These data may only be used for the analysis of the visit and click patterns on the web-site. **Black Stallion B.V.** uses this information ONLY to improve the quality and functionality of the web-site. These data are as much as possible made anonymous, and will not be provided to any third party.

## GOOGLE ANALYTICS

**Black Stallion B.V.** does NOT use Google Analytics or similar analytics specialists to monitor how visitors use the web-site, except Statcounter (countries and regions, no specific IP addresses).
